THE MODA Annual meeting was held at 4 p.m. on Sunday, November 16th at Laurel School within reach of our neighborhood. We appreciate Laurel graciously hosting the site of our meeting (thanks to Remona's contacts and arrangement). In the absence of President Holly Still, Remona Murray, Treasurer, presided.

Approximately 30 Menlo Oaks neighbors attended the meeting. Following introductions and welcome to new residents and the few old timers, the focus centered on traffic issues around Laurel School - The proposed possible changes involving Coleman Avenue as it intersects our neighborhood, changes proposed affecting Ringwood neighbors, and the concerns over bicycle safety of young children riding to school. There were questions about unsubstantiated numbers of children riding bicycles projected to use the Coleman/Ringwood connection to Laurel. Also at issue, are the changes to the parking area and pick-up process at the school. Holly, Remona and Marge Draper have been meeting with City of Menlo Park and the County representing our neighborhood's views.

## ELECTED OFFICIAL COMMITTEE CONSIDERS COLEMAN AVE.

As I reported in the May 08 Newsletter SMC Supervisor Richard Gordon gathered elected officials from the various cities and school boards to form a committee dedicated to look at both the long and short term changes regarding transportation in the areas around the schools.

Due to the lack of residents support, it is most likely that the committee has tabled the idea of a 1st Class bike lane on Coleman. There have been continuing discussions however in their meetings on improving the current easement to make it safer for walkers.

In the past many of the people involved in the discussion on this issue were very polarized, do nothing or take all the residence easement. The committee has been tasked to find middle ground while keeping true to their guidelines.

Using the following 5 guidelines:

1. Address Safety for Pedestrians, Bicyclists and Vehicles
2. Alleviate Congestion and Promote Traffic Reduction
3. Respect the Desires of the Neighborhoods
4. Improve Air Quality
5. Promote a Healthy Lifestyle

I look forward to learning and reporting more to you on this issue after the May 18th meeting of this Steering Committee.

## TRAFFIC SAFETY PANEL DISCUSSION

On Jan. 28th, the Laurel PTO hosted a panel discussion about traffic safety. The panel was made up of members of the Atherton & MP Transportation Dept., CHP, Atherton & MP Police Dept. & SMC Sheriff Office.

The focus was on the rules of the road for cars, bicycles, and pedestrians. There was also time spent on the current status of the Safe Routes to schools program. It finished with question by the audience for the panel.

Some of the more interesting comments that were made by the panel include:

- Pedestrians do not have the right to step out in front of traffic, they must wait for a break in traffic - apparently, if a pedestrian does so and there is an accident as a result, the pedestrian can be held liable.

- Bicyclists must follow the same rules as automobile drivers.
- Bicycles must ride single file with the youngest in the front .

(Some bicyclists disagreed with the police on many of these points)

- Do not allow passengers in the front seat to ride with feet up on dash - an accident could push them through the windshield or break ankles and feet. (passenger side air bag deployment can also cause a great deal of harm if the passenger is not seated properly).
- ZERO TOLERANCE for cell phone use while driving. If under 18, no cell phone use at all while driving - even hands free.
- Only allowed to use ONE ear plug while driving or biking (also recommended for pedestrians).

Q&A:

- Can bike be ridden on school campus - NO
- Can bikes be ridden across crosswalks - NO
- Where are bicyclists expected to ride when the bike lane is filled with carpool vehicles - in the road with cars, follow the same rules of the road as the cars.

## LAUREL SAFE ROUTES TO SCHOOL UPDATE

I have continued to following the City of Menlo Park progress on the Safe Routes to School Project. Prior to being awarded the State Grant the City of Menlo Park they had not yet gained the approval to finalize their proposed plans with the San Mateo Board of Supervisors or Transportation Dept.

Approved changes to Coleman only included the City installing a new crosswalk on the Westside at Willow Rd.

The unapproved plan calls for the County to provide a 3-Way Stop at Ringwood and Coleman Ave., additions of Crosswalks at Ringwood/Coleman, Lighted Crosswalk at Ringwood/Edge and narrowing of Ringwood from 11' to 10' from Coleman to Colby. No final decision has been made by the County to date.
